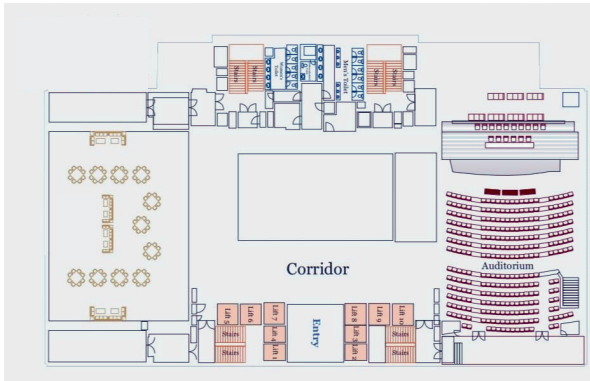
GROUND FLOOR S BLOCK, HIGH COURT OF DELHI
